

DETAILS FROM Q&A PERIOD

As a prior Lifetime CPCM, what time frame do I need to record Continuing Ed credit?

Lifetime are due to recertify 12/31/2023 CPE can go back as far as five years

Has NCMA determined what % of applications will be audited?

Around 25% of all application will be subject to audit.

Will I be subject to audit, if course was taken through NCMA?

All applicants are subject to audit. The Audit selection is done at random

I submitted certification application for CCMA on 4/18/2023 and submitted CPE certifications. When can I expect a response?

There is a 15 business turnaround time. I will be sure to check your application status and follow up with you via email.

Can I get a link to download the CPE Guide Overview that was discussed in the beginning of this presentation?

The updated CPE guide with be available on our website on May, 15th, 2022 as a free download.

What is the effective timeframe for any earned CPE?

CPE hours can go back as far as 10 years for a new application and 5 years for recertification.

Is there a way for me to verify a course through my local community college to ensure I am not wasting money and time taking a course that won't help me get my CPEs?

We do not typically do complementary reviews of CPE hours as it is a part of the review process. However, please feel free to email me at Kwanitria.denny@ncmahq.org and I'm happy to further discuss.

So, certification can look back 10 years prior to application and 10 years after application?

10 years from date of application submission date.

How many CPEs is required for new CPCM certification?

120 CPE hours.

Are podcasts (like the Contracting Officer's Podcast) eliglible for CPE credits? They are in government continuous learning credit.

Unfortunately, Podcast would not suffice for CPE with NCMA

Can I use some of the courses that I used to recertify my CFCM for my CPCM, which comes due for recert 3 years after the CFCM?

Yes, as long as the hours for your CPCM recertification are within the 5 year recertification window.

Is a transcript sufficient proof?

Yes

Can the same CPEs be used for both the CPCM and CFCM recertification if both recertifications are due at the same time?

Yes

Suppose your certificate from the provider only show credit hours, but doesn't specify CPEs or CEUs. How would you list the credit hours when uploading the documents?

50 mins or 1 hour of classroom instruction = 1 CPE

The best order is 1) earn prerequisite CPEs 2) apply for cert and 3) take certification exam

Can employer virtual training certificates of completion be used for CPE credit?

Yes, as long as the course aligns with the CMBOK Competencies

Is (1) hour of CPE equivalent of (1) hour of any training/program?

1 CPE = 50 mins or 1 hour of classroom instruction

If I am understanding properly I should or can go ahead and apply for certification and will have 10 years from the date of applying to achieve certification

No, CPE hours must be earned prior to application submission.

Are training courses with certificates from federal agencies applicable to the CPE process?

Yes, as long as they align with the CMBOK competencies.

To verify, the order of events is 1) apply for cert 2) earn prerequisite CPEs 3) take certification exam?

The order of events is 1) earn prerequisite CPEs 2) submit application 3) take certification exam

So CPE is given if we are the Presenter?

Yes

How do we know what college courses qualify as CPE hours?

The course would need to align with the CMBOK competencies listed in our CPE guide.

Do I have to be a member of NCMA in order to submit CPEs?

No, but there is a discounted application rate for members

Any plans to offer a CCCM prep course?

As of right now we do not have plans for a CCCM prep course, but we will let the community know if it's on the horizon!

Will there be other preparation course start this year, or in June 26th the only prep course for this year?

We will offer more start dates for prep courses later in the year. We usually have a prep course every quarter.

Do you offer a prep course for Certified Commercial Contract Manager?

We currently do not have a CCCM prep course. However, we do offer a CCMA practice exam.
