Recruiting Volunteers for Chapter Leadership Vacancies

Take the time to speak to potential volunteers and be sure to promote openings on your website, in your newsletter, and in social media. By promoting leadership

opportunities widely and making sure that everyone knows you are actively looking for volunteers, you may find additional candidates.

The elections for new chapter officers should be held in April. Selecting your new chapter officers in the spring has two benefits:

- It allows incoming and outgoing chapter officers ample time to work together on the year-end reports.
- It provides for a gradual transition so that important information on your chapter's processes can be passed down to the new officers.

The officer roster form used to submit the list of chapter officers for the upcoming program year is **here**. Following the election, submit the list of new and existing chapter officers to NCMA headquarters by May 15.

Phishing Alert

Unfortunately, chapters are continuing to report that they have been the target of phishing attempts, or email scams. To date, seven chapters have reported chapter presidents, or treasurers, being targeted.

If something seems wrong with an email you receive, trust your instincts. Several flags which may help you to detect a scam



include awkward grammar, a reference to an unknown vendor, or a strange "from" email address. While the phishing emails vary slightly, this is an example of a typical scam request:

Hello [Treasurer],

We have a pending payment in the amount of \$9,986.90 from a new vendor which needs to be processed as a same day wire transfer, I will forward the invoice once it's available.

Thanks, [President]

For the protection of your chapter, write policies into your bylaws reinforcing a commitment to always confirm requests to transfer funds by telephone, or in person. Only then should you follow the instructions in any email.

"Join Today" Information on Chapter Websites

Do you have a membership application form posted on your website? Quite a few chapters have outdated forms from several years ago. Rather than maintain the new version each year, we encourage you to link to the headquarters website. **This link** will take potential members directly to the most up-to-date membership information, so that you won't have to update your website when new forms and brochures are published.

Wow! Updated Chapter Rosters Now Available On-Demand

Updated chapter rosters are now available on-demand to provide you with the latest contacts! We think you will find it to be a big improvement over the old system, which had lists updated by NCMA headquarters just once monthly.

- To access the rosters, current chapter officers will first log in to NCMA's website.
- From "Connect With Peers," go to "Local Chapters," then navigate to "Chapter Leader Resources."
- Next click "My Chapter" from the left-hand navigation to generate your chapter's list.

The list you download will still contain join dates, expiration dates, and professional designations for your contacts. You may sort, filter, and save this information to reach your choice of contacts, then upload the list to your email tool.
